This agreement supersedes any prior agreements or understandings between the participant or parent and CPVBC concerning the subject matter of this agreement and will remain in effect until it is terminated or replaced by another written agreement
- 11. If any part of this Release of Liability, or the application of such provision, is rendered or declared invalid by a court of competent jurisdiction, or by reason of it requiring any steps, actions or results, the remaining parts of this Release will remain in force and effect.
